Fund objective

The Fund aims to deliver long term returns (over at least 5 years) by investing across a range of fund managers. The fund is actively managed and aims to remain within a low-medium risk profile, broadly in line with the Dynamic Planner 6 rating on their 1-10 risk scale.

The Fund will primarily invest in a diversified portfolio of global assets. These assets may include shares (equities), bonds, money market instruments and bank deposits. The Fund is likely to have a mix of higher-risk investments such as UK and overseas equities and lower- and medium-risk investments such as bonds, cash and cash-type assets. Any income generated is reinvested in the fund. The base currency of the Fund is Sterling.

General risks

Specific fund risks

Charges from capital: Expenses are charged to the investment. This could constrain future growth.

Currency exchange: Changes in the relative values of different currencies may adversely affect the value of investments.

Government securities exposure: The portfolio will invest in government securities issued or guaranteed by a permitted single state.
