What is this product?

Type

Unit linked investment fund. The value of the Vitality Invest Life Insurance Policy may be linked to this fund.

Objectives

The fund is designed to deliver long term returns through income and capital growth while remaining within a pre-determined target risk profile. Where possible, the fund aims to take into account environmental, social and governance (ESG) considerations. For example, it does this through exclusions which aim to limit investment in companies that may do harm or by investing a greater proportion of the fund in companies with higher ESG ratings. The fund will primarily invest in a diversified portfolio of mainly index-tracking funds across a number of asset classes. These asset classes may include shares (equities), bonds, property, money market instruments and bank deposits.

The Fund is likely to have mainly lower-risk investments such as cash, cash-type assets or bonds, and a minority of higher-risk investments such as UK and overseas shares.

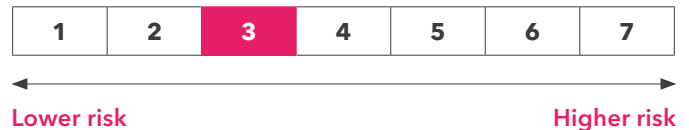
Intended retail investor

Customers looking for broad exposure to ESG considerations. They would like to invest for the medium to long term in a well diversified portfolio that has a greater focus on ESG considerations than traditional investment solutions.

They would like to generate long term returns but in a way where their money avoids companies whose products have negative social or environmental impacts and instead invest in those who are more focussed on sustainability issues. Customers who have a low attitude to risk. They would like to spread their investment over a range of different assets in different geographical regions and take a cost effective approach.

What are the risks and what could I get in return?

Summary Risk Indicator:



The risk indicator assumes you keep the product for 5 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this fund compared to other funds. It shows how likely it is that the fund will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

This fund does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme. The indicator shown above does not consider this protection.

Costs over time

The Reduction in Yield (RIY) shows the impact the total costs you pay will have on the investment return you might get. The total costs take into account any one-off, ongoing and incidental costs for the fund.

How long should I hold it and can I take money out early?

Recommended minimum holding period: 5 Years
